NARD Ownership Award

The National Community Pharmacists Association, founded in 1898 as the **National Association of Retail Druggists**, represents the nation's community pharmacists, including the owners of more than 23,000 pharmacies. The nation's independent pharmacies, independent pharmacy franchises, and independent chains dispense nearly half of the nation's retail prescription medicines.

Award Description

The award is inspired by the NARD name, which was for nearly 100 years the name associated with independent pharmacy. - Must be an owner or previous owner of an independent pharmacy.
- Must attend the upcoming NCPA Annual Convention and Exposition.
