
## Investing in Our Future: Growing Individual Donors

## **Disaster Relief Fund**

#### **FY24 Locations Served**

The foundation has provided disaster relief grants to pharmacies in 47 U.S. states and territories. In fiscal year 2024 alone, we provided 14 grants to pharmacies in need, helping pharmacies recover from fires, severe storms, flooding, vandalism, and burglary.


#### **Looking to the Future**

In fiscal year 2025, we anticipate an increase in number of grants provided to pharmacies in need. In part, due to the increased possibility of a turbulent hurricane season, but also because NCPA Foundation now has an Executive Director dedicated to helping grow the program and its impact.

#### **Measuring Progress**

#### Beyond the Numbers: Hearing Voices and Measuring Impact

The next section goes beyond statistics to capture the real-world impact of the NCPA Foundation Disaster Relief Grant program. We'll hear firsthand from pharmacy recipients about the challenges they faced before, during, and after the disaster, as well as the lasting impact of our grant support. We'll also explore the critical role independent pharmacies play in their communities and the lessons learned throughout this process.



## **Hawaii Wildfires**

The week of Aug. 6, 2023, a series of wildfires, driven by Hurricane Dora's winds, swept across Maui and the Big Island, bringing widespread devastation, especially in the town of Lahaina on Maui. The Lahaina Fire was the worst natural hazard disaster in Hawaii's history and one of the top five deadliest wildfires in the U.S. in recorded history, with 100 people confirmed dead. As damage assessments continued, it is clear that recovery from these catastrophic wildfires will take years.

#### One Pharmacy's Story:

"We are located in an area that has annual hurricane and tropical storm seasons. The majority of our emergency preparedness efforts have historically revolved around these hurricane seasons prior to the fires. The greatest barrier specific to this disaster was the inability to predict its magnitude and scale.

It seemed that each day we encountered a new challenge. Initially, it was very chaotic. Every entity was just working to address immediate needs. Our staff experienced extreme provider burnout and survivor remorse, and we had to take time to work through these challenges as well. But the consistent challenge throughout the wildfire disaster was really having the financial capacity to continue to purchase medications for the victims. The inability to work with PBMs and obtain immediate overrides required us to make the decision to absorb the cost and dispense medications that, at the time, we knew we could not recuperate."

"The NCPA grant was the first grant that provided financial relief for our small pharmacy as we continued to serve our community. It provided us with a glimmer of hope for us that we might pull through and survive financially."



## **Hawaii Wildfires**

#### **One Pharmacy's Story Continued:**

"After the disaster, we continued to work in Lahaina throughout the initial response and as health services were slowly restored. We were fortunate that state emergency proclamations supported our efforts and provided legal relief for the needs we were addressing. Specifically, we were allowed to stand up a mobile pharmacy at the comprehensive health center in Lahaina and used that space as a hub to deliver medications to the various shelters and hotel resorts housing survivors. It was a very emotional day as the Governor's emergency proclamations ended and we closed the door to that [emergent] mobile pharmacy. We are fortunate that through all of the grief, sadness and pain, we, in the healthcare field, experienced so many heart-warming moments.

I'll share the story of an elderly gentleman whom we located with our outreach team. He was sheltering in place and refused to leave his home. He was not found until day 3 after the fires. All the properties around him had burned down to the ground. His family home was passed down for six generations, and he shared with us that it was his responsibility and duty to make sure the house survived. He said he used his water hose to deter the fire from his home. He explained that if he were to perish with his house, he was ok with that, as he was fulfilling his duty to protect the family home to the very end. Amazingly, he was treated for just minor burns and smoke inhalation. When we asked him what more could we do for him, he simply replied, 'Are you guys ok? Can I give you water or canned food? I have plenty.' He and his house are still standing strong to this day.

Through all of the chaos and turmoil, we were able to witness true acts of love, kindness, and resiliency."

## **Hawaii Wildfires**

#### **One Pharmacy's Story Continued:**

Long-term impact: How will the grant's support continue to benefit your pharmacy and the community in the long run? Does your pharmacy need further assistance?

"We are very grateful for the NCPA grant and would welcome additional assistance. We have earned the community's trust and have fielded many requests to establish a more permanent presence in Lahaina. The community deserves a patient-centered pharmacy there, but for now, it is not financially viable for us to establish a physical presence yet. We still operate weekly community outreach and deploy our health educators to facilitate group discussions and help where they can and are actively working with partners on projects to improve health and wellness for the Lahaina residents."

Lessons learned: What are some key takeaways you've gained from this experience? How can we improve future disaster response efforts, especially for independent pharmacies?

"Never count out the little guys. The field of healthcare is very small, and it gets even smaller when you operate on an island. I take part in an active group chat with all of the pharmacists here on the island, and when the fires started and I asked for assistance via the group chat, most of the pharmacists (who work for corporate retail) were prohibited by their management to assist us in any way because of legalities. It was only because we were a small, locally owned pharmacy that we were able to mobilize and maneuver through the red tape. Secondly, know who your A-team is. The very first thing that I noted when we first arrived at the shelter while the fire raged on day 1 was that the same organizations that showed up throughout the COVID pandemic were the first to arrive to help. We worked closely with each other and knew we could count on each other. That really was the key to our response. All of us recognizing that no one entity or organization could have done it alone."

## Oklahoma Storms

On July 20, 2023 severe storms damaged roofs, snapped tree limbs in Blackwell, Oklahoma. Strong winds ripped roofs off of buildings. It rained inside Hutton Pharmacy for several hours due to the roof being torn off. In 2024, as of June 4th, Oklahoma has seen at least 100 tornadoes, nearly double the average yearly amount of 58. These destructive storms paired with tornadoes can prove to be especially deadly.

#### **From Crisis to Recovery:**

Before the disaster: How did your pharmacy prepare for potential emergencies? What challenges did you face in preparedness?

"We utilize Pharmacist Mutual as our insurance company. Outside of that and some development of policies and procedures that proved to be of limited help when it came time to put into practice, I would say we weren't very prepared. However, what we lacked in preparation we made up for in our response."

After the disaster: How has your pharmacy supported the community's recovery (e.g., extended hours, medication delivery, outreach programs)? Can you share any specific examples of how the grant made a positive impact on a patient/family?

"We were taking care of patients again within 24 hours. Our delivery schedule became necessary and far more robust (specifically with the 90-mile distance). I spent more on gas and put more mileage on a few vehicles than I'd care to reveal, but we made it work. Again, these funds were a contributing factor to making that possible."

## **Oklahoma Storms**

#### **From Crisis To Recovery Continued:**

During the disaster: What were the biggest challenges your pharmacy faced in serving the community in the face of the disaster event?

"We were without power and had an almost 100% product loss. Making sure our patients received their health needs elsewhere while also securing our data and prescription drugs was our immediate priority. We were able to get our server set up at our sister store in Edmond (90 miles away) within 24 hours to facilitate transfers or fill and deliver back to Blackwell. Insurance claims take a while so NCPA Foundation's grant allowed us to buy items needed to set up a temporary location in the multipurpose room at the sister location. We had set up a new pharmacy and created robust delivery schedules within 3 days of the loss of our building. We were in a temporary location in Blackwell within 3 weeks. The grant funds helped facilitate all of that."

## Long-term impact: How will the grant's support continue to benefit your pharmacy and the community in the long run?

"We will be in our new permanent location next month. It's been a long year but because of our response to the disaster and our team doing whatever they needed to keep servicing our community, we are supported as well or better than ever before. Grant funds were a resource to helping us maintain our good will and even increase our endearment to our community."

## Have you received any positive feedback from patients or community members regarding your pharmacy's role in disaster recovery?

"Our patients tell us every day how they are so glad we are still able to take care of them and were incredibly gracious to us in the immediate aftermath. The grant proved to be part of the equation that made that possible."

## **Disaster Relief Fund**

#### **Next Steps**

Our work does not stop here. We are committed to not only learning from our disaster relief grant program but also to make ongoing improvements to ensure we are serving the independent community pharmacies in their time of need.



#### **01.** Support Long-Term Recovery

Conduct follow-up surveys to assess long-term needs and partner with disaster relief organizations to connect pharmacies with resources beyond financial aid, such as construction firms, equipment suppliers, and mental health professionals.



#### **02.** Enhance Grant Flexibility

Consider expanding eligible uses of grant funds to include not just physical repairs but also mental health support for pharmacy staff impacted by disasters. Explore offering tiered grant amounts based on severity of damage or need.



#### 03. Expand Outreach

Communicate more regularly with state pharmacy associations and regional organizations as well as through NCPA to reach pharmacies in need.

## Dispose My Meds

#### 3 in 4 Adults Do Not Take Their Medicines As Directed

Dispose My Meds is a free online resource to help you find medication disposal programs at an independent community pharmacy in your neighborhood. This public service program is presented by the <u>National Community Pharmacists Association Foundation</u> and the <u>National Community Pharmacists Association</u> (NCPA).

The site encourages individuals to ask their community pharmacist about the best way to ensure safe and proper handling of their medications-from dispensing to disposal. The <u>website</u> (disposemymeds.org), provides free tips and resources to promote responsible, safe, and eco-friendly practices for prescription drug and medication disposal.

Note: If a drug take-back or collection program is not available in your area, please refer to Federal Guidelines from the Office of National Drug Control Policy on the proper disposal of medications.

## Community Pharmacy Involvement in NCPDP

A unique collaboration between the <u>National Council for Prescription Drug Programs</u> (NCPDP) and the NCPA Foundation, ensures that independent community pharmacists are engaged in the standards development process of NCPDP at this critical time of rapidly escalating HIT development. More than ever, the active engagement of independent community pharmacists is crucial as current decisions made in the NCPDP standards development environment are influencing the manner in which pharmacy will be practiced in the future.



#### Representation Is Key

Historically, independent community pharmacists have been less likely to participate in this important standards development process due to a myriad of other responsibilities. Encouraging a core group of influential, independent community pharmacists, who have been engaged and participated in the process since 2012, to remain active in the NCPDP standards development process, provide an additional forum for sharing their specialized expertise and go further in developing mutual understanding among pharmacy stakeholders and throughout the healthcare system.

NCPDP is a not-for-profit, multi-stakeholder forum founded in 1977 for developing and promoting industry standards and business solutions that improve patient safety and health outcomes, while also decreasing costs.



## Community Pharmacy Involvement in NCPDP

#### **Importance of Continued Support**

Without this core group of independent pharmacists, the pharmacy segment of NCPDP's membership would be represented by large chain pharmacy companies, big box store pharmacies and grocery store pharmacies. While these large companies and independent pharmacies have similar needs for using NCPDP standards (such as real-time claims processing and e-prescriptions), the innovation that happens in independent pharmacies results in different business needs.

These pharmacist participants have also been in the room for votes and in the hallways for strategizing on pharmacy workflow for a Medicare program that helps patients pay for their prescriptions starting January 2025. Just in time for system vendors to adapt workflows and for 2025 Part D Plan open enrollment, there are new codes for plans and pharmacies to use regarding a Medicare beneficiary's participation in the Medicare Prescription Payment Plan (M3P). Patients with a Medicare Part D Plan can elect into the program at any time, including during open enrollment, to help them spread the out-of-pocket costs over the course of the calendar year. The program will function like a coordination-of-benefits transaction (i.e. secondary payer) with a BIN/IIN, PCN, Group, and ID number. Pharmacies will see codes in paid or rejected claim responses with information about the patient's status in their plan's MPPP program. An FAQ approved at NCPDP's May 2024 Work Group meetings, concerns patients who have a supplemental plan that may have an amount due if the supplemental plan patient pay amount is greater than the Part D plan patient pay amount. The M3P only covers the patient pay amount from the Part D Plan but CMS allows the pharmacy to collect the difference. However, the patient may also request that the supplemental plan claim be reversed. Independent pharmacist involvement ensures there is a best practice recommended to handle special situations pharmacies encounter.

## Good Neighbor Pharmacy NCPA Pruitt-Schutte Student Business Plan Competition

NCPA and the NCPA Foundation established the Good Neighbor Pharmacy NCPA Pruitt-Schutte Student Business Plan Competition in 2004 to promote interest in independent community pharmacy ownership. The goal of the competition is to motivate pharmacy students to create the blueprint for buying an existing independent community pharmacy or developing a new pharmacy. The winning team receives two cash prizes: one prize to the team's NCPA student chapter and the other to the school in the Dean's name to promote independent community pharmacy at the school. Second and third place teams also receive cash prizes for their chapters. Other teams in the top 10 receive a cash prize to assist with student travel to the NCPA Annual Convention. The winning team also receives a trip for team members, the team advisor, and the dean, to the NCPA Multiple Locations Conference.

"When a dream is on the horizon, it is a great time to reflect on the path that brought you there and what needed to transpire to achieve it. Today, as a class of 2024 graduate of Palm Beach Atlantic University, I am under contract to purchase the only rural pharmacy within 50 miles in the Olympic Peninsula.

On my path, there were a number of experiences that were pivotal to achieve my dream. Two come to mind. The first was the NCPA Foundation's Ownership Workshop Scholarship in January of 2020 where I had the opportunity to attend the NCPA Ownership Workshop as a first year pharmacy student. The individuals that I met at the workshop encouraged me to pursue my dream of ownership right out of school and equipped me with knowledge to pursue ownership. The Ownership Workshop inspired me to lean into NCPA which ended with a road to NCPA Student Leadership Council Presidency and several other involvements which contributed to receiving the scholarship, networking with NCPA leadership, and connecting with an NCPA Board member to buy the pharmacy I am currently under contract.

The second was the NCPA Foundation's Presidential Scholarship I received in my 4th year of pharmacy school. This scholarship was special to me because my story came full circle. I am eternally grateful for the NCPA Foundation for their financial and reputational contribution to my journey."



#### John W. Dargavel Medal
